Special categories of personal data and/or sensitive personal data processed by Jager Real Estate BV

Jager Real Estate BV processes special categories and/or sensitive personal data of you insofar as provided by you. This may include information about:

Jager Real Estate BV collects this personal data because you have provided it to us. For example: you provide data when entering into an agreement with us, by entering your details on our website or by giving us your business card. We may also obtain your personal data from other sources, such as a business relationship, the Trade Register (Handelsregister), the Land Registry (Kadaster) or by using public sources.

The purpose and legitimate basis of the processing of personal data by Jager Real Estate BV

Jager Real Estate BV processes personal data for the following purposes:

- To be able to call or email you when necessary in order to be able to perform our services;

- We use Google Analytics on our website to provide personalized services

- Legitimate interest.

Automated decision-making

Jager Real Estate BV does not take decisions based on automated processing on matters that may have (considerable) impact on people. These are decisions taken by computer programs or systems without any human interference (for example automated refusal of an online credit application).

Retention period

Jager Real Estate BV stores your personal data no longer than strictly necessary to achieve the goals for which your data is collected or to comply with applicable laws and regulations. Jager Real Estate BV applies the following retention periods for the following (categories of) personal data:

Sharing or personal data with third parties

Jager Real Estate BV will not sell your data to third parties and will only share this information if this is necessary for the execution of the agreement, for example with a civil law notary, or if required by law. Jager Real Estate BV enters into data processing agreements with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Third parties engaged by Jager Real Estate BV who provide services as controller, for example a civil-law notary, are themselves responsible for compliance with the AVG for the further processing of your personal data.

Use social media

The website of Jager Real Estate BV contains buttons and / or links to promote or share web pages on social (media) networks or websites of third parties, such as LinkedIn and Instagram. Jager Real Estate BV does not supervise and is not responsible for the processing of personal data by and through such third parties. The use of these media is therefore at your own risk. Cookies and similar techniques

Jager Real Estate BV does not use cookies or similar techniques, but we do use Google Analytics to personalize our services.

Google Analytics

A cookie is placed on the website of Jager Real Estate BV from the American company Google, as part of the "Analytics" service. Jager Real Estate BV uses this service to keep track and receive reports on how visitors use the website. Google may provide this information to third parties if Google is legally required to do so, or insofar as third parties process the information on Google's behalf. Jager Real Estate BV has no influence on this. Jager Real Estate BV has allowed Google to use the analytics information obtained for other Google services.

The information that Google collects is made anonymous as much as possible. Your IP address is explicitly not given. The information is transferred to and stored by Google on servers in the United States. Google adheres to the Privacy Shield principles and is affiliated with the Privacy Shield program of the US Department of Commerce. This means that there is an appropriate level of protection for the processing of any personal data.

The Jager Real Estate BV website contains buttons to promote ("like") or share ("tweet") web pages on social networks such as Facebook and Twitter. These buttons work with pieces of code that come from Facebook or Twitter itself. Cookies are placed through this code. Jager Real Estate BV has no influence on this. Read the privacy statement of Facebook or Twitter (which can change regularly) to read what they do with your (personal) data that they process via these cookies.

The information they collect is made anonymous as much as possible. The information is transferred to and stored by Twitter, Facebook, Google + and LinkedIn on servers in the United States. Accessing, rectifying or deleting of personal data

This is to protect your privacy. Jager Real Estate BV will respond as quickly as possible to your request, in any event within four weeks. Jager Real Estate BV points out that you have the possibility to file a complaint with the national regulator, the Autoriteit Persoonsgegevens.
